#### Source Of Activity:

On 4/28/17 at approximately 2330 Hrs my partner Officer Chan, A #15074 and I, Officer Brown, E #16083 were assigned 3F92 working in full police uniform driving a marked black and white police vehicle when we recieved a radio call of a NCIC suspect located at 380 World Way lower level customs area. LAXPD Inc# 17-086248 LAPD Inc# 170428002839

#### **Investigation:**

Upon our arrival my partner and I met with the PR CBP Officer Delgado a CBP certified Drug Reconition Expert who stated that S- Waltman was on the CBP watch list for narcotics. CBP officers Uriarte and Beard (who are also Drug Recognition Experts) met S- Waltman on the jetbridge at gate 133 as he was attempting to board his flight on Norwegian Airlines (Flight #DY 7096) to London. Officer Delgado stated that S-Waltmans luggage was pulled off the plane and placed next to him on the jetbridge. A CBP Narcotics recognition certified K-9 (Officer Facine) allerted on S-Waltmans bags indicating the presence of narcotics. S-Waltman was then taken to a CBP secondary screening area. CBP Officer Uriarte then searched S-Waltmans Bags and descovered Narcotics inside his backpack. S-Waltman had three Cannibis Chocolate Bars, Two THC liquid Cigarettes, 15 Meth/Amphetamine capsules, and 23 Meth/Amphetamine capsules. In S-Waltmans possesion was \$736.10 US dollars an various denominations (See currency breakdown in report).

Upon our arrival all narcotics belonging to S-Waltman had already been seperated and sealed in CBP evidence bags and all origional packaging had already been discarded. Officer Delgado stated that the THC was confirmed using a three kit test revealing a Marquis reagent and the Meth/Amphetamine was confirmed using a four kit test revealing a Mayors reagent.

Officer Delgado stated that S-Waltman was set to return to Los Angeles on monday 5/1/17. Based on the duration of his trip along with the large quantities of pills our training and experience (40 hours narcotics training in the academy) lead us to form an opinion that the amount exceeds the amount that any person can consume in that time frame. Thus the large quantity of pills plus the large quantity of US currency are associated with narcotics sales.

A check for wants and warrants revealed a warrant for 23152 CVC in the amount of \$5000 out of Los Angeles.

3L60 Sgt. Ino #02498 responded to our location and approved the transportation.

### Arrest:

S-Waltman was taken into custody for 11351 H&S and taken to LAPD Pacific Division for booking.
